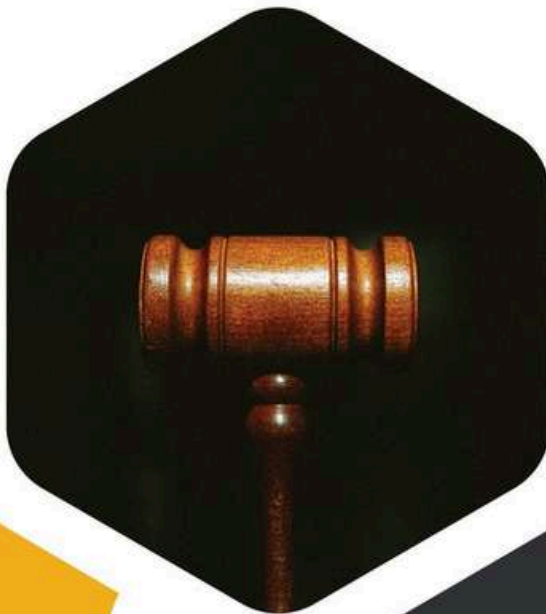


OUR BRAND STORY

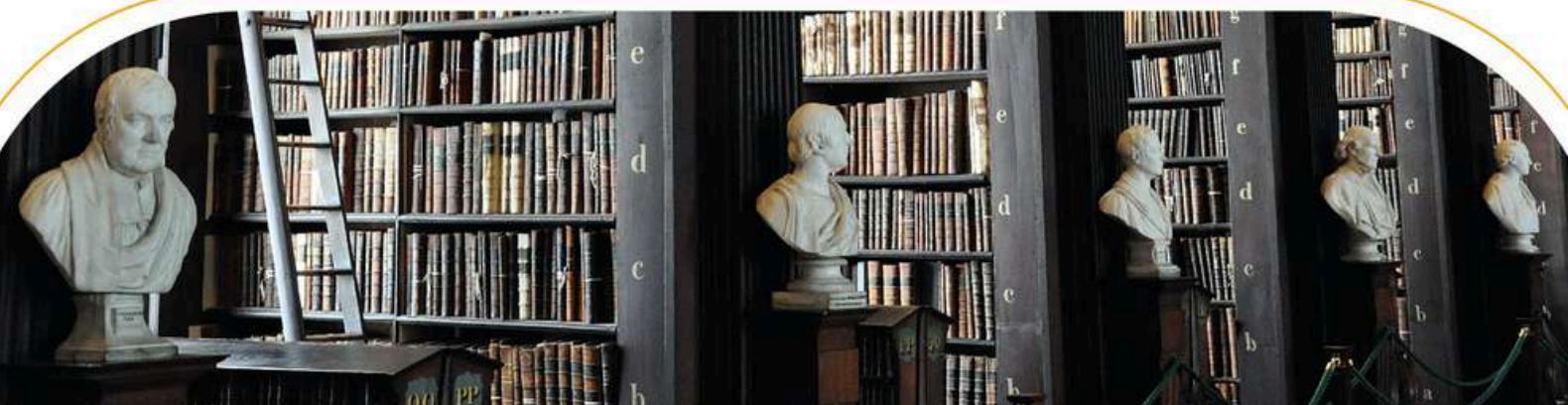
